CoC Homeless Grant Competition

Each year (except 2020) HUD releases a Notice of Funding (NOFA) for the HUD Continuum of Care (CoC) Homeless Grant Competition.

Eligible Uses:

- 1. Permanent Housing
 - Permanent Supportive Housing
 - Rapid Rehousing
- 2. Supportive Services Only (for Coordinated Entry)
- 3. HMIS

2021 CoC Competition

 Each year (except 2020) HUD releases a Notice of Funding Availability (NOFA) for the HUD Continuum of Care (CoC) Homeless Grants Competition.

Threshold Criteria

- Coordinated Entry Participation
- •Housing First and/or Low Barrier Implementation
- Document Secured Minimum Match
- Active CoC Participant
- Acceptable Organizational Audit and Financial Review
- Project Costs are eligible (24 CFR 578 Subpart D)

What is Housing First

- Direct, or nearly direct, placement of targeted or prioritized homeless people into permanent housing
- Supportive services are offered and readily available, but are not required to remain in housing.
- Assertive outreach to engage and offer housing to homeless people, including unsheltered people
- Low demand approach that accommodates client alcohol and/or substance use and symptoms of mental illness
- Continued effort to provide case management

Competition Selection Process

- HUD is expected to continue to require CoCs to rank project applications in order of priority for funding.
- Tier 1=A defined percentage of how much \$ is needed to fully fund all projects eligible for "renewal funding"
- Tier 2=The balance of what is needed to fully fund the renewal projects plus any "CoC Bonus" amounts
- Projects ranked in Tier 1 are much more likely to be funded than projects ranked in Tier 2.

New Projects, Expansions & Domestic Violence Bonus

This year the available amount from HUD for New Projects and New Project Expansions through the CoC Bonus is approximately \$183,735.

HUD offered a Nationwide "bonus" competition for projects that assist survivors of domestic violence, dating violence and stalking in 2018 and 2019.

Local 2021 Domestic Violence Bonus is \$551,205

Eligible Costs

- Acquisition, Rehabilitation, or new construction of PSH
- Leasing or Rental Assistance
- Supportive Services
- Operating Costs
- HMIS
- Project Administration up to 10% for new projects
