The following applications did not pass the threshold review.

Lutheran Services submitted a Host Homes Project that did not meet match requirements and did not qualify as Housing 1st. Section 6J source of match provided by the organization is \$2,400. An additional commitment of \$159,983 would be required. Additionally, on page 30 5d. HUD has determined hat the applicant does not meet Housing 1st. Lastly, the grant was submitted after the deadline.

Sea Haven SSO DI submitted an application due to the budget and narrative not matching, it was too difficult - to understand. Ultimately, the application was not considered complete, as the budget was inconsistent with the narrative. Including, but not limited to minimal costs used to operate the drop-in center, and the budget was duplicative of the SSO – Street Outreach request.

The Sea Haven SSO – Outreach grant is a program partially operated currently by Sea Haven. This grant was seeing federal funds to supplant/supplement current operations. Even though the YAB liked this activity, the constraints on the budget required them to prioritize funding for other project types.
